Plan Description:

The Lower Manhattan Development Corporation was created in the aftermath of September 11, 2001 by Governor Pataki and then-Mayor Giuliani to help plan and coordinate the rebuilding and revitalization of Lower Manhattan, defined as everything south of Houston Street. The LMDC is a joint State-City corporation governed by a 16-member Board of Directors, half appointed by the Governor of New York and half by the Mayor of New York. LMDC is charged with ensuring Lower Manhattan recovers from the attacks and emerges even better than it was before. The centerpiece of LMDC's efforts is the creation of a permanent memorial honoring those lost, while affirming the democratic values that came under attack on September 11. The United States Department of Housing and Urban Development appropriated \$2 billion to fund the Lower Manhattan Development Corporation's initiatives.

Recovery needs:

The World Trade Center attacks resulted in a staggering loss of life and extensive physical destruction to Lower Manhattan. Approximately 30 million square feet of commercial space was damaged or eliminated, and seven buildings in the World Trade Center site were completely leveled. Critical transportation infrastructure was disrupted or obliterated, including the PATH station, the 1/9 subway line and sections of Route 9A and Church Street. Vehicular access to the area south of Canal Street was prohibited for seven days. As a result of the tragedy, residential occupancy rates in the immediate region dropped to 60%, over 100,000 jobs were displaced, and small and large businesses struggled to maintain viability.

Location Description:

The Project Area is located in Lower Manhattan on two sites: (i) the WTC Site, an approximately 16 acre super-block, bounded by West, Vesey, Church, and Liberty Streets; and (ii) the adjacent two city blocks south of the WTC Site, one bounded by Liberty, Washington, Albany and Greenwich Streets, and the other bounded by Liberty, West, Cedar and Washington Streets, and a portion of Liberty Street between those parcels and the WTC Site (collectively, the Southern Site). Specific parcels potentially to be acquired consist of (a) 130 Liberty Street, on which the Deutsche Bank building is situated (the 130 Liberty Site), (b) 155 Cedar Street, on which the St. Nicholas Church was situated (the Church Site), and (c) 140 Liberty Street, which is currently unoccupied (the Milstein Site). All of the structures situated on these parcels were destroyed or severely damaged on September 11, 2001. The potential acquisition of the Church Site and the Milstein Site, if undertaken by LMDC, will be the subject of a subsequent partial action plan.

Activity Progress Narrative:

130 LIBERTY BUILDING--- ACTIVITY DESCRIPTION---The 130 Liberty Street parcel is targeted for redevelopment as part of LMDC's proposed World Trade Center Memorial and Redevelopment Plan (WTC Plan). On August 31, 2004, LMDC, pursuant to an agreement established in February 2004 that resolved a dispute between the former owners of the building and its insurers, acquired the building at 130 Liberty Street (130 Liberty), which had been severely damaged as a result of the events of September 11, 2001. Throughout the acquisition and deconstruction process, LMDC has and will engage the services of environmental consultants to conduct environmental testing and characterization of the building materials, dust, and mold. LMDC and its contractors will also work to coordinate their efforts to achieve the goals of incorporating M/WBEs and minority and women employees into the project workforce. In an effort to keep residents, workers, elected officials, and the public informed about the developments of 130 Liberty, LMDC has developed a comprehensive outreach plan that includes, but is not limited to, the establishment of a 130 Liberty Street Advisory Committee (composed of immediate area residents, businesses, elected officials, Community Board 1 Representatives, and others); the distribution of periodic electronic updates (E Updates); and frequent attendance at Community Board 1 meetings.

PUBLIC OUTREACH AND PARTICIPATION--For the quarter ending December 31, 2005, LMDC held a public information session at the Marriott Financial Center in Lower Manhattan on October 24, 2005. This information session provided updates on the progress of the deconstruction, including the Air Monitoring program and Emergency Action Plan. Participants were invited to ask questions on different topics that included air monitoring, deconstruction logistics, emergency procedures, and community relations. OEM and 130 Liberty project contractors participated in the meeting.--On November 28, 2005, LMDC also convened a meeting of the 130 Liberty Street Advisory Committee, which included representatives from

the New York City Fire Department (FDNY) and the Office of Emergency Management (OEM). Topics of discussion surrounded emergency protocols and community involvement. LMDC also announced that it would provide support for emergency response training of volunteers in and around the 130 Liberty Street area through the Battery Park City Community Emergency Response Team (CERT). --On December 7, 2005, LMDC attended the WTC Redevelopment Community Board 1 Committee meeting along with representatives of FDNY,OEM, and the New York City Police Department to provide a general project update and specifics on emergency protocols, as well as the plans to expand the Battery Park City CERT to include the area surrounding 130 Liberty St.--The E Updates have continued to serve as a useful means of providing notification to various Lower Manhattan stakeholders of LMDC public meetings, notice of work, and revisions to the Phase I Deconstruction Plan. During the quarter ending December 31, 2005, nine e-updates were sent to over six hundred subscribers, providing information on the 130 Liberty project status.

130 LIBERTY BUILDING DECONSTRUCTION--- LMDC received approval from the regulatory agencies of the revised Phase I Deconstruction Plan on September 8, 2005. As a result of this approval and pursuant to board authorization, LMDC entered into contracts for scaffolding and related abatement work, and for the cleaning and deconstruction of 130 Liberty. Scaffolding work continued during the quarter ending December 31, 2005.-- URS Corporation continues to provide site maintenance on an ongoing basis. LMDC expects to expeditiously erect scaffolding on the building enclosing the curtain wall to allow for the building's exterior cleaning and a more efficient deconstruction process. LMDC will then move forward with cleaning and removal of asbestos and contaminants of concern and finally structural deconstruction of the building, with the expected to commencement of work during summer of 2006. AIR MONITORING --- Since taking ownership of 130 Liberty, LMDC expanded the air monitoring program to include air sampling on the building and at the street level. Since the approval of the Phase I Deconstruction Plan twelve air monitors have been installed.

BENEFICIARIES--- This activity will contribute to implementation of the World Trade Center Memorial and Redevelopment Plan (WTC Plan). Full implementation of the WTC Plan will benefit the thousands of relatives and friends of the nearly 3,000 victims of September 11, 2001 and February 26, 1993, as well as the many survivors of those tragic events. Beneficiaries will also include area residents, workers, and businesses, as well as the millions of visitors to the WTC site and Lower Manhattan. ---Area Residents, Workers, and Businesses--- An estimated 39,166 residents live within a 0.5 mile radius of the site, of which 6,540 are considered Low-Moderate income. Moreover, 61,400 workers and 2,685 businesses operate within a 0.25 mile radius of the WTC site.

LMDC GENERAL ADMINISTRATION --- LMDC maintains a staff and office space to carry out its planning and community development activities, including general management, oversight, monitoring, and coordination. In addition, LMDC provides local officials, businesses, and citizens with information about programs. The following provides information on activities occurring during the guarter ending December 31, 2005. For information on previous quarterly reports, please visit the LMDC website at www.renewnyc.com. PUBLIC PARTICIPATION --- ADVISORY COUNCIL MEETINGS LMDC holds Advisory Council meetings that allow for a broad spectrum of groups affected by the World Trade Center attacks, including victims' family members, business owners, arts and cultural institutions, and downtown residents to consult with LMDC on issues of concern to their respective constituencies. On October 19, 2005. LMDC held a Families Advisory Council meeting to update victims family members on the design and development phases of the Memorial. Present at the meeting were LMDC staff as well as lead architects Michael Arad (Handel Architects) and Carl Krebs (Davis Brody Bond). -- PUBLIC HEARINGS, MEETINGS, AND OTHER OUTRECH-- LMDC conducts additional outreach initiatives on a continuous basis, such as mailings to city, state, and federal elected officials, civic and community organizations, and victims families, participates in Community Board meetings, and meets regularly with community groups, civic organizations, and public officials to ensure that the opinions of those who were affected are taken into account. The LMDC website also solicits public feedback on all of its initiatives, including WTC site planning, transportation, Lower Manhattan neighborhoods, the WTC Site Memorial, and Partial Action

CULUTRAL ENHANCEMENT FUND During the quarter ending December 31, 2005, LMDC conducted extensive outreach throughout Lower Manhattan to organizations interested in submitting applications for funding as part of the proposed Cultural Enhancement Fund. LMDC provided information through mailings, posted advertisements in weekly and daily newspaper s, as well as posting information on its website. Organizations interested in submitting applications for the proposed Cultural Enhancement Fund were required to do so by December 22, 2005.--SECTION 106 COORDINATION AND OUTREACH A coordinated Determination of National Register Eligibility dated March 31, 2004 found the entire WTC Site eligible for listing on the National Register of Historic Places, LMDC continues to provide informational updates to consulting parties regarding the ongoing planning process at the WTC Site, consistent with the processes that brought about the listing, and a Programmatic Agreement signed between LMDC, the Advisory Council on Historic Preservation, and the New York State Historic Preservation Officer. The consulting parties generally consist of victims' family members, residents of Lower Manhattan, civic organizations, and preservationist groups, On October 20, 2005, LMDC held a Section 106 consulting parties meeting, which included updates on the following topics: Memorial Museum programming, Memorial design, resource protection and artifacts at the WTC Site.

130 LIBERTY STREET DECONSTRUCTION PROJECT PUBLIC OUTREACH – Since mid-2004, LMDC has engaged in public outreach activities related to the deconstruction of the building at 130 Liberty Street in response to expressed community and public concerns. In order to ensure that this project is as inclusive and transparent as possible, LMDC developed a comprehensive outreach plan to inform and educate the public on the deconstruction of the building at 130 Liberty Street. LMDC also formed the 130 Liberty Street Advisory committee, composed of immediate area residents and businesses, elected officials, and Community Board 1 representatives, that provide additional stakeholder input. On October 24, 2005, LMDC held a public information session to update the public on the deconstruction of the 130 Liberty Street Building. On November 28, 2005, LMDC held a 130 Liberty Street Advisory Committee, which included representatives from FDNY and the Office of Emergency Management, where emergency protocols and community involvement were the subject of discussion.

LONG-TERM PLANNING - LOWER MANHATTAN TRANSPORTATION PLANNING: COMMUTER AND AIRPORT ACCESS ALTERNATIVES ANALYSES -- In the wake of the 9/11 attacks, improved access to the region's airports has become a critical piece in the revitalization strategy for Lower Manhattan and in the district's long-term goal of maintaining national and international competitiveness and viability as a commercial center. Equally as important is improved access for Long Island, one of the area's fastest growing regions and a critical labor pool for Lower Manhattan. The LMDC, in coordination with the Port Authority of New York and New Jersey (PA), the Metropolitan Transit Authority (MTA), and the City of New York (the City), coordinated Lower Manhattan Commuter Access Alternatives Analysis to identify and evaluate long-range opportunities to provide enhanced rail access to the Lower Manhattan Central Business District from John F. Kennedy International Airport (JFK) Airport in Queens, and from the Long Island Railroad (LIRR) Station in Jamaica, Queens. For information on previous quarterly reports, please visit the LMDC website at www.renewnyc.com. For the guarter ending December 31, 2005, Public Advisory Committee and Technical Advisory Committee meetings were held in October 2005 to discuss the goals of the project (that were revised based on public input), the alternatives (including all those identified by the public) and the proposed criteria that would be used to evaluate the alternatives. In the Fall 2005, commuters and JFK Airport customers were surveyed to better understand their current and potential future travel behavior.

Activity Progress Narrative:

The WTC Business Recovery Grant Program, by far the largest of the disaster recovery grant programs. ended December 31, 2002. In October 2002, LMDC and ESDC worked with HUD to process a sub-allocation of \$150 million to BRG as part of a total \$350 million sub-allocation to three existing programs administered by ESDC, as described in Partial Action Plan No. 2. In August 2003, pursuant to the Partial Action Plan No.4, an additional \$74.5 million was sub-allocated to the BRG program. The final LMDC allocation for the BRG program is \$224,500,000.--This program ended December 31, 2002 and final payments were made in 2003. Since the end of the program, some funds were returned to the allocation of BRG funds, as noted below. The amount was less than .05% of the overall grant amounts disbursed, so there is no significant change to any reporting statistics. --As of September 30, 2005 a total of 8,214 businesses (including 282 not-for-profit organizations) received 8366 grants totaling \$213,990,259 using LMDC's \$224.5 million supplemental BRG allocation. (In Q1 2005, \$80,921 was returned to the LMDC allocation reducing the actual dollar amount of BRG grants using the LMDC funding as of June 30, 2005 since the previous guarter.) The average value of LMDC-funded BRG grants disbursed to eligible businesses over this period was \$26,051. BRG total employment (including wage earners and owners) at small businesses assisted with the LMDC program funds was 63,459. Based on the LMDC BRG allocation alone, the average number of wage earners and owners at the establishments of BRG-assisted businesses in the Eligible Area was approximately eight. Seventy percent of total employment at assisted establishments (or 44,437 wage earners and proprietors) were low- and moderateincome earners (defined as annual income up to \$50,250). Low-income earners (defined as less than \$31,401 per annum) reflected 50% of total employment (or 31,805 wage earners and proprietors). (The income limits noted here reflect the limits set by HUD's 2002 HOME income limit chart for a 4-person household.) --When viewed by sub-areas within the Eligible Area, the LMDC-funded portion of the BRG program shows that most of the grants disbursed went to small businesses in the Restricted Zone and the area surrounding it south of Canal Street. A total of 5,323 grants were disbursed to 5,227 businesses in these two areas, with a total value of \$181 million (or 84.6%) of the total disbursed LMDC sub-allocation to the BRG program. As of June 30, more than the prorated share of the estimated 19,600 small businesses south of 14th Street received grants through the LMDC allocation of BRG program funds, which contributed to the retention of 90% of the prorated share of the estimated 225,000 jobs in the Eligible Area considered at risk in the Final Action Plan. As of December 31, 2005, all funds have been disbursed for the ESDC administered portion of this activity. Also during the guarter \$15,228 was returned to HUD. The balance of the obligated funds not yet disbursed has been obligated to small businesses, as was outlined in Partial Action Plan No. 4.

Activity Progress Narrative:

CHINATOWN TOURISM AND MARKETING PROGRAM--- In 2003, LMDC in conjunction with the September 11th Fund, announced the beginning of a large scale tourism and marketing campaign for Chinatown an area greatly impacted by the decrease in visitors as a result of September 11th and the outbreak of SARS in Asia in 2003. --- The campaign was officially launched on May 10, 2004 with a great deal of media coverage, including local Chinatown media, mainstream media, and tourism industry-specific media. The launch of the Explore Chinatown Campaign included the launch of the website: www.ExploreChinatown.com, branding Explore Chinatown, as well as the Chinatown brochure. For additional information on previous quarterly reports, please visit the LMDC website at www.renewnyc.com. For the quarter ending on December 31, 2005, the Explore Chinatown Team members and Advisory Committee continued their efforts to promote Chinatown. On October 15, 2005, the third Taste of Chinatown, took place with an estimated 50,000 visitors, making this event the most successful to date. Taste of Chinatown included tasting stations and cultural and family oriented activities to entertain visitors. A Chinatown to China sweepstakes was also held. A post event survey of 51 participating businesses conducted by Asian Women indicated the benefit of the event. Among other results, over \$85,000 was generated in tasting plate sales and related inside sales during the event; 100% of those surveyed said they would participate in the next Taste of Chinatown and felt that the street closure for the event was very effective and worthwhile. Also occurring during the quarter, the Explore Chinatown Campaign again enlisted the use of subway cards to promote upcoming events in Chinatown. 2006 Lunar New Year activities were posted in over 40% of NYC Transit's subway fleet starting October of 2005 and remain on view through February 2006 and possibly longer. In addition, 75,000 TakeOne handout flyers with deals in Chinatown were distributed throughout the NYC subway and bus system. With an approximately 4.5 million ridership on an average weekday, this creates a tremendous exposure for Chinatown and the Explore Chinatown Campaign. Concurrently, full page color ads ran in travel related magazines such as the City Guide magazines (circ. 61,596) in 5 weekly issues during the periods of October 6th through November 3rd; the October issue of the Courier magazine (circ. 6,000); and the November/December issue of the Destinations magazine (circ. 6,000) to emphasize all that Chinatown has to offer. And for the first time, the Explore Chinatown Campaign initiated a Holiday Shopping promotion for Chinatown. By using radio ads on the WABC group radio stations (including WABC, WPLJ, ESPN, and Radio Disney) and ads in 2 daily newspapers, amNew York (circ. 304,829) and Metro New York (circ. 303,026), reinforcing messages were used to urge holiday shopper to shop Chinatown for the best gifts and deals. Promotions to the internet users were also considered. Ad banner, buttons and links on Expedia, Orbitz, and Cheaptickets were used during the period of October 15 to December 15 to promote the Explore Chinatown website and the Holiday shopping promotions.

And according to a preliminary report by M. Silver, in October, 99 clips were generated with a Total Audience figure of 18,470,948; 32 clips were generated in November with a Total Audience figure of 4,771,141; and 18 clips were generated in December with a Total Audience figure of 5,325,212. And these are just preliminary figures, the numbers will surely go up for November and December as more of the clips arrives. For the same period, the Chinatown Information Kiosk reported a total of 25,879 visitors and the Explore Chinatown website reporting 116,107 visitors with both reporting a surge during special events. All these efforts did not go un-noticed as the prestigious Society of American Travel Writers selected the Explore Chinatown campaign as the recipient of the top Aaron D. Cushman Award, the Gold Prize for the Best Marketing Campaign for 2004-2005, at the organization's 50th anniversary conference and first SATW Public Relations Award Ceremony in Las Vegas in late September. Winning the Gold Prize for the Best Marketing Campaign is a testament to the Explore Chinatown team efforts, including brochure, website, map, kiosk, advertising, public relations, community outreach and services, tour product development, and Working Group and Advisory Committee involvement. It is definitely a noteworthy achievement for the Chinatown community. In the coming months, the Explore Chinatown Campaign will be planning for the Lunar New Year festivities as Chinatown celebrates the Chinese Lunar New Year 4704, the "Year of the Dog".

COLUMBUS PARK PAVILION --On June 14, 2003, HUD approved the allocation of funds for renovation of the Columbus Park Pavilion. LMDC and the New York City Department of Parks and Recreation (Parks Department) worked jointly to conduct the environmental review. The Parks Department continued to meet with members of the Chinatown community to discuss the plans for the renovation of the Pavilion and of the Park. The estimated total cost of the Columbus Park Pavilion renovation had increased as a result of the enacted Coordinated Construction Act, and the increased cost of construction materials. The restoration of the Pavilion's historic features also resulted in the increased cost of the project. The WTC Employment Training Assistance Program (ETAP), established by the Empire State Development Corporation (ESDC), in cooperation with the Lower Manhattan Development Corporation (LMDC) and the New York City Economic Development Corporation (EDC), provides assistance to small businesses and not-for-profit organizations to offer training opportunities to their employees in Lower Manhattan. An initial \$10 million had been allocated to ETAP from a \$2 billion federal appropriation made available to LMDC through HUD. In August 2003, a reallocation of ETAP funds to the BRG program was made and the ETAP budget was reduced to \$500,000. This reallocation was made based on an evaluation of the program's popularity and the additional funding needs of the BRG program. --As of May 12, 2003 ESDC no longer accepted eligible applications for ETAP due to the reallocation the funds. Through that date, ESDC had received 24 applications for training assistance. As of June 30, 2005, thirteen grants were disbursed to eleven businesses for \$345,909 to assist in training 333 new and retained employees. One application had been completed and was pending disbursement upon satisfactory review by ESDC. As of December 31, 2005, all funds have been disbursed for this activity, and this activity is completed. There will be no further reporting on this activity in future reports.

HISTORY AND HERITAGE IN DOWNTOWN NYC (HHD)/Museums of Lower Manhattan--- On June

14, 2003, HUD approved the allocation of \$4,664 million for History and Heritage in Downtown NYC, History and Heritage in Downtown NYC (HHD), now called the Museums of Lower Manhattan campaign, is a joint initiative of various Lower Manhattan museums whose mission is history and heritage. HHD is a marketing initiative that will promote downtown as a cultural destination. HHD has provided for the creation of various marketing and advertising materials, a website www.MuseumsOfLowerManhattan.org, and other activities that promote Lower Manhattan Culture. Participating museums include: Castle Clinton National Monument; the Eldridge Street Project, Inc.; Federal Hall National Memorial; Fraunces Tavern Museum; Lower East Side Tenement Museum; Museum of Chinese in the Americas; Museum of American Financial History; Museum of Jewish Heritage- A Living Memorial to the Holocaust; Smithsonian National Museum of the American Indian; New York City Fire Museum; New York City Police Museum; South Street Seaport Museum; the Skyscraper Museum; the Statue of Liberty National Monument and Ellis Island Immigration Museum; and the Unwavering Spirit Exhibit, St. Paul's Chapel. For the guarter ending December 31, 2005, Brand Champs submitted the results of a second Tracking Study of the Museums of Lower Manhattan campaign in November 2005, The professionally conducted, internet based survey of 750 pre-screened individuals found that the campaign has been effective in directionally raising awareness of the brand Museums of Lower Manhattan from 25 % in 2004 to 35% in 2005. It has also increased awareness of the museums outside the tri-state area. 22% of those surveyed indicated stated that they recommended the Museums of Lower Manhattan to people who live outside the tri-state area, compared to 15% in the 2004. The data suggests that the campaign and media buy are increasing awareness and motivating visitation. The Museums supplied initial attendance figures for 2005, and, while not complete, they suggest a steady increase in visitorship over 2004. During December 2005, many of the museums indicate the adverse impact of the transit strike in New York City on their operation from December 20th through 22nd. Also during the guarter, Bandujo, Donkers and Brothers continued print advertisement placements in various tourist publications, local newspapers and magazines. Website visitation for the guarter was lower than in the previous guarter. This may coincide with the fact that no radio placements were run during the quarter. In December 2005, Bandujo migrated the museum website from a server hosted by LowerManhattan.info to one contracted by Bandujo. This server change will permit faster corrections and updates to the website, as well as allow for faster, more accurate, and easily accessible website reports. CTM Brochure Display, Inc. distributed 95,000 Museums of Lower Manhattan map brochures for the period of October - December 2005. There are currently 44,900 maps in CTM's reserve. Dan Klores Communications was also successful in placing several stories, including an article in The New York Times on the move and expansion of the Museum of America Finance to a new historic Wall Street location. and placements in local newspapers regarding events at the Museum of the American Indian, and Smithsonian Institute. The MOLM Campaign also began a new project that will Include professionally shot and edited short films and additional B-roll footage for each of the 15 museums. The individual films and B-roll footage will highlight the museum's history, exhibits and programming and will allow the campaign and the museums themselves another format for promotion. Tourist and educational venues will be sought to showcase these informational films. This project is expected to be complete in the next quarter. Other MOLM Campaign initiatives anticipated for the next quarter will include a Kids Passport; an updated Museums of Lower Manhattan Brochure; updated banners for the Vesey Street Pedestrian bridge; and a promotional agreement with the Hilton Hotels of New York City, which will allow purchasers of the Hilton Discovery Downtown package to enjoy a 2 for 1 admission at many of the museums as well as a 10% gift shop discount.

REHABILITATION/RECONSTRUCTION OF A PUBLIC IMPROVEMENT --- To advance the revitalization of Lower Manhattan and support the stabilization and expansion of the collective residential community, the Hudson River Park Trust (HRPT) proposed the creation of a set of new tennis courts and the conversion of the courtyard formerly a parking lot of the Pier 40 complex at Houston Street into recreational field space for use primarily as baseball and soccer fields. The tennis courts, opened on October 12, 2004, replace a set of courts that previously existed in Battery Park City. The new Pier 40 fields will provide a much-desired community amenity and allow either two games of soccer or baseball or one game of football simultaneously. These recreational spaces will serve thousands of residents and attract thousands more to the downtown area. As with other fields that the Hudson River Park Trust operates, the Trust expects the fields to be used daily on a year-round basis from early morning until near midnight. The fields will yield substantial benefits for residents and workers in the Lower Manhattan communities that were most affected by the attacks of September 11, 2001. --- The tennis courts, located along the River's edge between West Houston and Canal Streets, were designed by Mathews Nielsen Landscape Architects, P.C. in conjunction with the Trust's Design and Construction team headed up by Marc Boddewyn. The court's waterfront location offers not only a majestic setting, but are also easily accessible to the substantial and growing residential communities along the west side of Lower Manhattan and Greenwich Village. Three tennis courts were constructed: two doubles courts and one singles court. The courts are enclosed via a chain link fence with windscreens and surrounded by granite curbing, asphalt walkways, and planting areas. New storm drains and electrical provisions for future light poles have also been constructed as part of this project. The courts are free and open to the public and will operate from 6:00 A.M. to dusk during the spring, summer and fall. --- Construction is complete on the recreational fields at Pier 40, but for several punch list items including final installation and connection of fire safety system and coordination with Pier 40's current building fire suppression system. The overall Pier 40 Athletic Field Construction project provides roughly 163,000 square feet of new, multi-use ballfields within the courtvard of Pier 40. As of September 2005, the main field has been completed. including the installation of high quality artificial turf and sports lighting for nighttime play. Renovated bathrooms and new emergency exit corridors have been provided to satisfy code requirements. As the final step in the construction of this project, the HRPT has recently reopened the existing roof-top soccer field with newly installed artificial turf, and a new roof-top passive open area has been created to satisfy the community's demands for such a space. Construction for this quarter on the Pier 40 athletic fields included several change order and punch list items such as final fencing around new passive space, netting repairs/replacements, fire safety coordination with existing equipment and code compliance inspections. The punch list items at the Pier 40 athletic fields has been completed, and all aspects of the project are now open and operating.

The centerpiece of the memorial is "The Sphere for Plaza Fountain," a monument that had been dedicated to fostering world peace that sat atop a granite fountain in the center of the 5-acre World Trade Center Plaza. The Sphere was commissioned by the Port Authority and created by sculptor Fritz Koenig in 1971. The attack on September 11th transformed The Sphere into an icon of hope. LOWER MANHATTAN COMMUNICATIONS OUTREACH CAMPAIGN --- In June 2003, LMDC announced the launch of a communications outreach campaign to inform Lower Manhattan residents, employees, and visitors of upcoming short-term, quality of life improvements. The campaign began when LMDC staff and volunteers fanned out across Lower Manhattan to distribute thousands of palm cards and place 100 posters in local businesses and restaurants. The communications outreach campaign is one of the elements outlined in Governor Pataki's call for short-term, quality-of-life improvements in Lower Manhattan. The campaign's three components include: the creation of informational kiosks at strategic locations downtown that will double as visitor centers; the development of branded marketing materials; and the distribution of LMDC printed materials and electronic updates. More than half of the campaign's funds have been allocated for the creation, design, construction, and maintenance of the two informational kiosks: the Downtown Rebuilding Information Kiosk which is located at the new World Trade Center Path Station and the Chinatown Kiosk which is located between Canal, Baxter, and Walker Streets. The campaign also allocated funds for staffing the WTC Path Station kiosk for two years. For the quarter ending December 31, 2005, the WTC kiosk had 42,420 visitors in October, 52,320 visitors in November, and 49,315 visitors in December. The Chinatown kiosk, a partnership with other agencies, had 8,827 visitors in October, 8,002 visitors in November, and 9,050 visitors in December. Both kiosks are stocked with current informational collateral about Lower Manhattan and the rebuilding efforts.

LIVING MEMORIAL--The Living Memorial project is an Internet-based information tool that seeks to centrally archive and make accessible information related to those lost on September 11, 2001 and February 26, 1993. September's Mission Foundation is working in partnership with the New York State Museum, New York State Archives, E-Trade Financial, and the NY Historical Society on the Living Memorial Project. September's Mission is a not-for-profit organization created to support the development of a memorial at the World Trade Center site. Living Memorial will ensure the preservation of the memory of those lost and the historic circumstances surrounding the events of September 11, 2001 and the 1993 WTC bombing by allowing victims' family members, friends and children to provide material about their loved ones including photos, videos, letters, newspaper clippings chronicling the victim's life, letters, artwork, poetry, etc. The public will also be invited to provide material regarding these tragic events. Over time, this collection of information will serve as a living memorial and a lasting repository. To ensure privacy, the Living Memorial project will allow family members to restrict access to their loved ones library. To date. September's Mission has hired one full-time Executive Director, dedicated to the project to oversee the day-to-day functions of the program. They have also hired a full-time Program Coordinator to support the administrative duties of the project. Staff held a public meeting on September 7, 2005, to unveil the website template to the public, and to allow for public comment. The organization is also working to find a computer company to provide software and programming assistance.

It is intended to enhance the coordinated efforts of the City of New York. New York State, and federal agencies throughout the long-term process of rebuilding and redevelopment. The Program consists of a website, a newsletter, and informational construction signage that focuses on Lower Manhattan and delivers the most accurate and timely information about the area's rebuilding progress to the area stakeholders including residents, businesses, and visitors. This is accomplished through marketing, advertising, stakeholder outreach, and strategic planning. The centerpiece of the Program is a comprehensive website. www.LowerManhattan.info, which offers regularly updated news and information for area residents, workers, and visitors. --- Since September 1, 2003, LMDC has funded the Program with HUD funds. However, October 2005 was the last month the Program received funding from LMDC/HUD. The Program continues moving forward with oversight and funding from another organization and therefore the following statistics are only for the month of October 2005. The total number of stories since September 2003 ending October 2005 are as follows: total feature articles. 179; total news stories, 140; and total week in review (media story summaries), 107. The average number of articles uploaded per week for the month was seven. Stories this month varied from highlighting the Memorial Foundation for raising more than \$101 million to numerous construction features. This was in addition

PROJECT AREA--The site for commemoration on September 11, 2004 was identified as Lot 26 in Battery Park City. Support has been indicated by the Battery Park City Authority, owner of the site, for this year. Several other sites are being considered for future years, including sites within the vicinity of the World Trade Center site and Battery Park City. The Battery Park City Authority, the Mayor's office and other City agencies have committed to identifying and securing sites for the next five years.

Activity Progress Narrative:

TRIBUTE IN LIGHT-- On March 11, 2002, marking the six-month anniversary of the World Trade Center tragedy, two beams of light rose into the night sky from a site just north of the World Trade Center site to honor those lost on September 11th, and to celebrate the spirit of all New Yorkers who have worked to rebuild and renew New York City. Conceived in the aftermath of the September 11th tragedies, the display called Tribute in Light is an artistic gesture bringing together the vision and talent of numerous individuals who, shortly after the attacks, independently envisioned twin beams of light rising from downtown New York. Organized by the Municipal Art Society and Creative Time, Tribute in Light was conceived by architects John Bennett and Gustavo Bonevardi of PROUN Space Studio, artists Julian La Verdiere and Paul Myoda, architect Richard Nash Gould, and lighting designer Paul Marantz. Universally embraced by the public, the Governor and Mayor announced the return of Tribute in Light for one night each year on September 11th as part of the City's commemoration. Tribute in Light provides a valuable public service as an interim memorial, ensuring that on each anniversary of September 11th, the thousands of people who were killed that day and the loss of the World Trade Center and its impact on New York City and beyond is commemorated. LMDC funding provided for the purchase of the lights (which had previously been rented), technical support, and on-going maintenance for the display for five years. The Tribute in Light of September 11, 2005 was successfully and momentously displayed from the Battery Park Tunnel Garage, where it will remain through 2008.

SHORT-TERM CAPITAL PROJECTS - MILLENNIUM HIGH SCHOOL --- In September 2003, Governor George E. Pataki and Mayor Michael R. Bloomberg announced the opening of the first Lower Manhattan public school to open in the aftermath of the September 11th attacks. Millennium High School, located in the financial district, gives preferential consideration to those who live in Lower Manhattan, providing a rigorous education to the growing number of families making downtown their home. The school is the first open admission high school specifically serving Lower Manhattan students. The area served is all of Lower Manhattan south of Houston Street. Millennium High School opened in September of 2003 for 220 9th and 10th graders, with 11th and 12th graders to follow as the school continues its construction/expansion. Three floors of what was once commercial office space have been converted into classrooms, administrative offices, and other school facilities. At full enrollment, the Millennium High School will serve 500 students. A new class will be added each year until enrollment is full.

However, the jersey barriers, French pedestrian barriers, pickup trucks, and other ad hoc measures that were installed have decreased the quality-of-life and ease of access for local residents, businesses, workers, and visitors. LMDC PLANNING - ENVIRONMENTAL --- LMDC sought the advice and counsel of law firms and environmental consulting firms on retainer on environmental and land use requirements and matters relating to LMDC's planning and development initiatives in Lower Manhattan, including (1) the World Trade Center Memorial and Redevelopment Plan (WTC Plan) for the World Trade Center (WTC Site) and certain parcels to the south (Southern Site), (2) cultural and community improvement projects, and (3) public information, outreach, and participation efforts relating to the foregoing activities. With the assistance of the firms, LMDC reviewed the requirements in the June 2004 Record of Decision and Findings Statement for the WTC Plan, including technical issues relating to the April 2004 Programmatic Agreement pursuant to Section 106 of the National Historic Preservation Act as well as the deconstruction of 130 Liberty Street. In addition, analyses and documentation were prepared for Hudson River Park Segment 3 improvements and planning studies for several improvement projects sponsored by The City of New York relating to parks, streets, and areas along the East River waterfront in Lower Manhattan. LMDC has consulted with numerous state and federal agencies, including Advisory Council on Historic Preservation (ACHP), NYS Department of Environmental Conservation, NYS Office of Parks, Recreation and Historic Preservation (NYSHPO), National Park Service, and US Environmental Protection Agency. LMDC has continued to seek the assistance of its environmental counsel and consultants on environmental initiatives and coordination efforts by and among private, city, state, and federal entities involved in rebuilding efforts in Lower Manhattan, including the transportation recovery projects sponsored by Federal Transit Administration (FTA), Federal Highway Administration (FHWA), and Federal Emergency Management Agency. As part of the ongoing Section 106 processes relating to federally-funded projects in Lower Manhattan, LMDC attended Section 106 consulting parties meetings held by PA on the WTC Transportation Hub and LMDC itself conducted a meeting with the Section 106 consulting parties on the WTC Memorial and Redevelopment Plan on October 20, 2005 to review additional design and planning progress on the World Trade Center Memorial and Memorial Museum.

LMDC PLANNING - OFF-SITE INITIATIVES --- An integral part of LMDC's efforts to revitalize Lower Manhattan are a series of studies that identify short-term and long-term solutions to the challenges facing downtown neighborhoods in the wake of September 11th. These studies include a Chinatown Access & Circulation Study, a Brooklyn Bridge Anchorage Study, a Study of the Fulton Street Retail and Cultural Corridor, a Public Realm Enhancements Study, and an Urban Design and Traffic Study for Greenwich Street South. These studies include data gathering on existing conditions, identification of planning and design opportunities and strategies, and implementation plans. The Financial District has very limited open space, and much of what does exist is privately owned and has been closed since September 11th due to security concerns. LMDC and urban design consultant Smith-Miller+Hawkinson conducted a Public Realm study of the area to identify places within the Financial District where strategic enhancements could maximize accessibility and usability of the area's limited public realm. As a result, Louise Nevelson Plaza, bound by Maiden Lane, Liberty Street and William Street, one of the only publicly-owned spaces in the Financial District, has been identified as the best opportunity for a redesign that would increase the site's accessibility and appeal. Planning for this project is complete and design is currently underway. Design refinements are being made as the project is being reviewed by the City in preparation for construction, scheduled for fall 2006. Through the amended Partial Action Plan 4, LMDC included this project as part of the Neighborhood Parks and Open Spaces initiatives. In this quarter, the designers further refined the plan to reduce project costs. They are also preparing final construction documents for the project.

Activity Progress Narrative:

WOLRD TRADE CENTER PLANNING --- In August 2002, LMDC invited architects and planners from around the world to participate in a design study regarding the future of the World Trade Center site and surrounding areas. As a result of the extensive public selection process that followed the invitation, on July 10, 2003, LMDC entered into a contract, jointly with the Port Authority of New York and New Jersey, with Studio Daniel Libeskind, LLC, for design consulting services relating to the redevelopment of the World Trade Center site. The work for this contract includes but is not limited to, the creation of an integrated site plan reconciling multiple uses on the WTC site and the establishment of design guidelines for commercial development. On September 17, 2003, LMDC, along with the Port Authority and Studio Daniel Libeskind, released a refined plan, followed by the January 2004 selection of ; Reflecting Absence; by Michael Arad and Peter Walker for the memorial, as a result of an international Memorial Competition. Work has continued on the integration of the memorial design into the overall plan for the World Trade Center site. This reconciliation has been on-going and involves detailed work by LMDC, Port Authority, and the memorial design team. In 2004, LMDC, the Port Authority of New York and New Jersey and Studio Daniel Libeskind continued to refine the plan in a number of key areas and those plan changes resulted in the preliminary adoption of the General Project Plan for the World Trade Center Memorial and Cultural Program on December 16, 2004. For the guarter ending December 31, 2005, work focused on the programming of the Performing Arts Center building, and the revisions of the Snohetta building program, size, design, and location. LMDC and the WTC Memorial Foundation are exploring possibilities for September 11th related programming in this building. In addition to refinements to the WTC plan, Studio Daniel Libeskind also continued to work extensively with LMDC, the Port Authority, the City of New York and the World Trade Center leaseholders on drafting and revising the Commercial Design Guidelines for the World Trade Center site. These guidelines are intended to set out basic urban design principles for the overall site redevelopment and allow for the vision of the WTC plan to be fulfilled over time. The design guidelines include a chapter on sustainable design and green construction prepared by LMDC, the Port Authority, and Silverstein Properties. In addition, LMDC continued working jointly with the Port Authority on planning of the Southern Site, including Liberty Park and St. Nicholas Church, in conjunction with the Vehicle Security Center and all other infrastructure elements on and under this site. Also, LMDC and the WTCMF advanced work on a Pedestrian Study for the Memorial Quadrant and its immediate area for the purpose of assessing pedestrian desire lines and volumes as well as appropriate queuing locations on the Memorial Plaza for the millions of future visitors to this site.

The Pace University Green Roof is the result of extensive cooperation between Pace University, the U.S. Environmental Protection Agency (EPA) Region 2, the New York City Department of Environmental Protection (DEP), and the New York City Department of Design and Construction (DDC). DEP and DDC will coordinate the 35,000 square feet Green Roof project, making it the largest green roof in the Northeastern United States. --LMDC's allocation for the Green Roof is designated for planning and design of activities. The Pace Green Roof has received support from a broad range of community stakeholders, including elected officials and government representatives as an ¿innovative¿ project that will serve the Lower Manhattan community at large, including visitors, residents, civic organizations, and students. The Green Roof will provide an additional venue, accessible to the community, that residents and community organizations will be able to reserve for special events, programs, lectures, and educational activities at no cost. Pace University would also provide free public tours of the green roof, on a weekly basis, for educational purposes, providing information on the development and needs of green roofs, the environmental benefits of green roofs, and other research activities. Moreover, Pace University will continue to explore additional opportunities that will provide expanded public access to the Green Roof for the Lower Manhattan community.

NEIGHBORHOOD PARKS & OPEN SPACES -- In a commitment to improving the short-term quality of life of residents, business owners, and workers in Lower Manhattan, the LMDC has committed funds toward the renovation, creation, and/or rehabilitation of numerous neighborhood parks and opens spaces throughout the area. The parks identified as part of this activity include: Drumgoole Plaza, Wall Street, Coenties Slip, Tribeca Park, East River Park Ballfields, Brooklyn Bridge Plaza, Sara D. Roosevelt Park, Bowling Green, Al Smith Playground, Washington Market Park, Old Slip, Columbus Park Landscape, Battery Bosque, and Louise Nevelson (identified as part of the amended in Partial Action Plan 4). The New York City Department of Parks & Recreation is enhancing each of these sites with horticultural elements such as flowering trees, ornamental shrubs and planting beds, as well as new benches, lighting and decorative paving. Active recreation amenities were incorporated at many of the sites as well. Parks & Recreation has reached out to neighboring corporations and individuals in an effort to support the revitalization of the sites. Design and improvements to Louise Nevelson Plaza will be administered by the LMDC and NYC Department of Transportation. As of the December 31, 2005, the following parks are complete: Drumgoole, Tribeca Park, Bowling Green, East River Park, Al Smith Playground, Brooklyn Bridge Plaza, Old Slip, and Washington Market Park. For additional information on previous quarterly activity, please visit the LMDC website at www.renewnyc.com. Except for Louise Nevelson Plaza, work at the remaining sites listed below is ongoing or substantially complete. These include: WALL STREET TRIANGLE -- Two entire blocks of Lower Manhattan's East River waterfront at Wall Street were transformed into green space on the north side of the existing roadway, framing views to Trinity Church. Planting beds, shade trees, an expanded sidewalk, decorative fountain, contemporary benches and new lighting will enhance the open space. At the east end of the site, the terminus of this allée will be an artist-designed fountain, made possible by a donation from Deutsche Bank. The allée is formed by unique granite and glass benches. This new, contemporary park will provide a lunch time respite for Wall Street workers and a gathering space for all to enjoy. The western half of the site was available for public use in June 2004. The remaining work on the site was substantially complete at the end of June 2005, at which point the public took use of the site. The fountain is in the final design phases now, with fabrication scheduled to begin in the spring. Based on census tract data, an estimated 27,541 residents are located within a .5 mi. radius, of which 34.3% are of Low-Moderate income, and 125,471 workers are located within a .25 mi. radius. COENTIES SLIP -- The land marked bluestone sidewalk extends into a new plaza space featuring new benches, a granite plaza and, soon, a new sculpture feature. Planting beds are installed as part of this new work, supplementing the lone tree at this site. Hardscape work on the site was substantially complete in December 2004. Remaining work was completed in early summer 2005. The sculpture, funded by Goldman Sachs, is in the preliminary fabrication stages, with installation expected for late spring. Based on census tract data, an estimated 20,325 residents are located within a .5 mi. radius, of which 21.3% are of Low- Moderate income, and 114,687 workers are located within a .25 mi. radius Coenties Slip. BATTERY PARK BOSQUE - In collaboration with the Battery Conservancy, a ¿horticultural destination; was created in the Bosque area east of Castle Clinton. New plantings, paths, evening lighting, a fountain, and a world-class ornamental garden will be installed. Phase I of the Bosque project was completed early June 2005. The fountain installation was completed in August 2005. Based on census tract data, an estimated 11,742 residents are located within a .5 mi. radius, of which 15.2% are of Low-Moderate income, and 47,550 workers are located within a .25 mi. radius. COLUMBUS PARK The northern part of this Park, including the pavilion and the areas around the sports field, will be reconstructed. (The restoration of the pavilion, funded in part through a separate partial action plan will include a multi-purpose activity space, new restrooms, and barrier-free accessibility. The pavilion construction work is currently underway.) In the park areas connecting the ballfield and the pavilion, a gathering space including new benches, decorative pavements, game and picnic tables, an accessible drinking fountain, new plantings, attractive fencing, and lighting has been created The construction of the landscape work is complete with some additional planting work scheduled for the Spring along Baxter Street. SARA D. ROOSEVELT --A new park entrance has been constructed at Canal and Chrystie Streets, which will open onto a new synthetic turf

field and a new track. These additions plus new benches, plantings, lighting, paths, and a reconstructed park wall and fence will provide for a safer, more attractive multi-use area. The turf field at the site was substantially completed in November 2005. The track surface was substantially complete and the remaining fence panels were installed by the end of 2005. Based on census tract data, an estimated 92,990 residents are located within a .5 mi. radius, of which 66% are of Low-Moderate income, and 17,039 workers are located within a .25 mi. radius of Sara D. Roosevelt Park. LOUISE NEVELSON PLAZA the Plaza was identified as an additional site in the Amended Partial Action Plan 4 as part of Neighborhood Parks and Open Spaces. Louise Nevelson Plaza, bounded by Maiden Lane, Liberty Street, and William Street, is one of the only publicly-owned open spaces in the Financial District and has been identified as the best opportunity for a redesign that would increase the site's accessibility and appeal. A new design has been developed which better highlights the Louise Nevelson sculptures located on the plaza; adds more appropriate trees and increases seating and improves the plaza lighting so that the space can be used both during the day and at night. Construction is scheduled to begin this summer. Based on census tract data, an estimated 30,473 residents are located within a .5 mi. radius, of which 35% are of Low-Moderate income, and 149,915 workers are located within a .25 mi. radius of Louise Nevelson Plaza.

Activity Progress Narrative:

RIVER TO RIVER 2005 ACTIVITY DESCRIPTION-- LMDC continued its commitment to enriching Lower Manhattan's cultural community and supporting its economic growth through its support of the 2005 River to River Festival. First launched in 2002 and funded in part by LMDC in that first year, and subsequently funded in 2004, the River to River Festival, the largest free cultural arts festival in New York's history, is comprised of more than 500 free cultural events that take place throughout Lower Manhattan from May through September. These events include a diversity of music, dance and other cultural activities, many provided by world-renowned performers. The River to River Festival was created specifically to help in the revitalization of Lower Manhattan after September 11, 2001, and attracted more than one million people in each of its first two years. LMDC's support for the 2005 River to River Festival included the following two components: 1) baseline sponsorship for the Festival as a whole, and 2) sponsorship of a new series called ¿Arts on the Horizon, which focused on the Joyce Theater, Signature Theatre, and Drawing Center. The baseline sponsorship supported the Festival's umbrella marketing campaign, allowing the Festival to deliver the summer-long, high-impact communications platform and supporting the costs associated with delivering the Festival's mission of presenting free, world-class programming in Lower Manhattan as an economic driver for the community. The presenting sponsorship allowed the Festival to produce ¿Arts on the Horizon, ¿ a series of high profile special events with the Joyce, Signature, and Drawing Center, with recognition of the LMDC and HUD as the host sponsor of the series. Spending provided in this report was for River to River Festival 2005.

For the purposes of the Grant Program the area of focus has been divided into three zones. These zones are as follows: Zone 1 is defined as the area south of Chambers Street and west of Nassau and Broad Streets, including all buildings which face on those streets and the entirety of Battery Park City. Zone 2 is defined as the area outside Zone 1 but south of Canal Street and southwest of Rutgers Street, including all buildings which face on those streets. Zone 3 is defined as: the area north of Canal Street and Rutgers Street; south of Delancey and Kenmare Streets; and east of Lafayette Street in Manhattan, including all buildings which face on those streets with the exception of Canal Street and Rutgers Street.

Activity Progress Narrative:

LMDC RESIDENTIAL GRANT PROGRAM (RGP) --- The Residential Grant Program was launched in August 2002 to provide assistance to residents and families who lived downtown on September 11, 2001 and who agreed to continue to reside in Lower Manhattan, as well as offer financial incentives to new residents who agreed to make a two-year commitment to live downtown. On August 15, 2002, LMDC announced the availability of applications for the \$281 million Residential Grant Program. Over 140,000 applications were distributed throughout the Lower Manhattan area at over 130 locations including community centers, elected officials offices, Community Board offices, senior centers, residential developments, libraries, and at two full service LMDC Residential Grant Program Community Offices located in TriBeca and Chinatown. --- The deadline for the LMDC Residential Grant Program was May 31, 2003 with a grace period for some exceptions, --- In order to minimize the risk of loss from fraud. LMDC has retained a Compliance Auditor and investigative team, which operate a fraud prevention hotline and other initiatives. LMDC's Vice President for Investigations provides in-house expertise on fraud prevention and has day-to-day oversight responsibility for the investigative team. -- As of December 31, 2005, 39,801 applications were approved. Of the 39,801 approved applications representing approximately \$227,235,354.97 million in grants, LMDC will distribute 30,922 September 11th Residents Grants, 26,712 2-Year Grants, and 8,122 Family Grants to individuals. LMDC will distribute 1,465 2-Year Grants to 77 businesses. --- There has been a positive response to the LMDC Residential Grant Program. Applicants include residents that lived here prior to September 11, 2001 and remain committed to the area, families making Lower Manhattan their home, and new residents making two-year commitments to Lower Manhattan. Lower Manhattan is comprised of many diverse neighborhoods. 58 percent of the approved applicants are low- or moderate-income individuals and families, 20 percent of the approved applicants are families. Since the Residential Grant Program was first announced in February 2002, there has been a tremendous resurgence of interest in moving to Lower Manhattan, which is reflected in the increase in residential occupancy rates. For example, the occupancy rate of Battery Park City was 60 percent after the attack, rose to 74 percent shortly after the announcement of the draft plan, and is now over 95 percent. 53 percent of the residents in zone 1, the area closest to the World Trade Center site, are new residents to the area since September 11, 2001. The new and renewed commitment of residents to the area, despite the disaster, provides a strong foundation for the revitalization of Lower Manhattan.

The Small Firm Attraction and Retention Grant (SFARG) was intended to help retain and create 65,000 jobs throughout the Lower Manhattan area. The deadline for applications was December 31, 2004, but companies that signed leases anytime between 9/1/2004 and 12/31/2004 had a grace period through April 1, 2005 to apply. There were also allowances for companies fitting out space and not moving by these deadlines. This program is managed by ESD in cooperation with EDC in accordance with a Final Action Plan and an Amended Action Plan accepted and approved by HUD. Assisted firms will have an indirect impact upon businesses employing an additional 30,000 individuals. SFARG provided up to \$5,000 per employee for: 1) Companies or not-for-profit organizations that newly locate up to 200 employees below Canal Street and sign new five-year leases before 12/31/04, or 2) Businesses with up to 200 employees below Canal Street with leases expiring by 12/31/04 that renewed or signed new fiveyear leases. All initial applications for the SFARG program have been received and processed. SFARG2 applications, the second installment of SFARG grants to eligible applicants that received the first half of their grant, will be accepted into 2007. ESDC has used its original \$105 million allocation for the program, and has begun drawing on LMDC's \$50 million sub-allocation. To date, we have made over 2,450 grants to 2,418 businesses for over \$107 million. For the guarter ending December 31, 2005, grant disbursements were made to 52 businesses for SFARG1 and SFARG2 from the LMDC \$50 million suballocation.

Thereafter a definitive agreement was prepared, negotiated, and signed by 140 Liberty Street Associates as the seller, LMDC's signature was subject to further review and approval, including an amendment to Partial Action Plan 9 to allocate additional funds for the transaction. Amended PAP9 was approved by HUD in October 2005. In November 2005, the transaction was approved by the New York State Public Authorities Control Board. In December 2005. the LMDC Board authorized the signing of the agreement and it was signed by LMDC on December 30. 2005. The parties are now preparing for closing on February 1, 2006.

Additionally, the LMDC Board authorized an amendment to Lord's contract for additional institutional development services, including coordination between the interpretive and architectural programs of the Memorial Center; refinement of the institutional plans developed in the first phase for the Memorial, Memorial Center and Visitor Center;

and possibly other services. Specific services to be provided include the creation of Room Data Sheets and the review of Design Development documents. Beneficiaries will also include area residents, workers, and businesses, as well as the millions of visitors to the WTC site and Lower Manhattan. --- Area Residents, Workers, and Businesses--- An estimated 39,166 residents live within a 0.5 mile radius of the site, of which 6,540 are considered Low-Moderate income. Moreover, 61,400 workers and 2,685 businesses operate within a 0.25 mi radius of the WTC site. Implementation of the WTC Plan will directly benefit these groups, as well as the larger Lower Manhattan community. As outlined in the WTC Plan Generic Environmental Impact Statement (GEIS), construction of the completed WTC Plan building program would create an estimated 50.830 person-years of direct employment (one person working fulltime for one year), and 45,698 person-years of indirect employment in New York City. Operation of the completed WTC Plan is estimated to create approximately 39,412 to 40,533 direct full-time equivalent jobs, as well as additional 56,057 to 56,460 indirect full-time equivalent jobs generated in New York City and State. ---Lower Manhattan Visitors--- Current demand reports indicate that memorial and related uses at the WTC site are projected to result in approximately 4.6 million visitors per year upon completion in 2009, with a surge of up to an additional 1.9 million visitors in the first year.

WEST STREET PEDESTRIAN CONNECTIONS--With the opening of the Port Authority temporary PATH station in November 2003, and the full re-occupation of the World Financial Center (WFC), it is projected that 9,400 pedestrians per hour cross Route 9A between Albany and Murray Streets in the rush hour peak. An estimated 6,000 of those pedestrians are expected to cross Route 9A (West Street) at Vesey Street during the peak hour, and most of the remaining pedestrians are expected to cross at Liberty Street. It was concluded that a temporary pedestrian bridge across West Street and a protected pathway from the PATH Station were needed to meet the pedestrian demand. Additionally, it was determined that enhancements were required for a temporary pedestrian staircase connection to the Liberty Bridge that was built after the September 11th attacks. The Vesey Bridge was built by the New York State Department of transportation (NYS DOT), and the Vesey Walkway and Liberty Street pedestrian enhancements were built by the Port Authority of New York and New Jersey (PANYNJ). The Vesey Bridge main span over West Street, the Bridge Extension, the West and East escalators, and the bridge's elevators are open, and the construction phase of this project is complete.
