- Asbestos samples at Station 1 (Southwest Area [sidewalk bridge level]) and Station 2 (Southeast Area [sidewalk bridge level]) on August 25, 2007 were not collected. The stations were not accessible on account of a fire at 130 Liberty Street that caused unsafe conditions in the vicinity of the stations.
- Asbestos result at Station 4 (Northwest Area [street-level]) on August 25, 2007 is not available as this sample was overloaded with carbonaceous particulate and completely obscured and could therefore not be analyzed.
- Asbestos samples at Station 1 (Southwest Area [sidewalk bridge level]), Station 2 (Southeast Area [sidewalk bridge level]) and Station 4 (Northwest Area [street-level]) on August 26, 2007 were not collected. The stations were not accessible on account of a fire at 130 Liberty Street that caused unsafe conditions in the vicinity of the stations.
- Asbestos samples at Station 14 (West Face - South end at corner [scaffolding level]), Station 15 (South Face - East end at corner [scaffolding level]), Station 16 (East Face - North end at corner [scaffolding level]) and Station 17 (North Face - West end at corner [scaffolding level]) on August 25 and 26, 2007 were not collected. The stations were not accessible on account of a fire at 130 Liberty Street.
